

The site of the execution of Col. James Fannin and 340 of his men. Following their surrender, Gen. Santa Anna under the death-to-foreigners decree, ordered the execution of Fannin and his troops.

Because of this, national interest was sparked in the Texas Revolution, and soon volunteers were streaming forward to aid the Texians in their endeavor.

Today, an annual re-enactment is held to commemorate the event. The presidio, along with the Mission Espiritu Sanctu, is visited by thousands or tourists and schoolchildren each year. Special events, including guided tours and living history exhibits, provide visitors with a realistic view of a pivotal point in the struggle for Texas' independence.
